## ANNOUNCEMENTS

### CPSC Issues Consumer Warnings on Baby Loungers, Carbon Monoxide Detectors, and More

Throughout the month of June, the Consumer Product Safety Commission (CPSC) issued several public health and safety notices to consumers, warning the public to stop using products posing a range of hazards. These unilateral warnings are issued because the manufacturers have not agreed to a recall or offered a remedy to consumers:

- [DHZJM Baby Loungers](#): Suffocation and Fall Hazard; Infant Death Reported.
- [Smoke and Carbon Monoxide Detectors](#): Risk of Serious Injury and Death; Detectors Fail to Alert Consumers to Smoke in a Fire.
- [Xastro Fuel Bottles](#): Poisoning, Burn, and Flash Fire Hazards; Violation of the Children’s Gasoline Burn Prevention Act.

## TOP RECALLS

[June 27, 2024 CPSC](#); The Baseus Magnetic Wireless Charging Power Banks, sold at Amazon.com, AliExpress.com and Baseus.com, have been recalled because the lithium-ion battery in the power banks can overheat, posing a fire hazard. Units: About 132,000.

[June 27, 2024 CPSC](#); REI recalled its Co-op Cycles REV 12-, 16-, or 20-inch Kid’s Bicycles with training wheels because the training wheel assembly knob can loosen and detach from the bicycle, posing fall and injury hazards to the riders. Units: About 75, 860.

[June 25, 2024 CPSC](#); MGA Entertainment recalled its Miniverse Make It Mini Sets with Liquid Resins because the sets contain resins that, when liquid, can cause skin, eye, and respiratory irritation or sensitization when inhaled, touched, or ingested by children or adults. The resins contain acrylates (hydroxyethylmethacrylate “HEMA” and isobornyl acrylate “IBOA”) in amounts prohibited in children’s products by the Federal Hazardous Substances Act. After the resins cure, they no longer present this hazard. Units: About 21 million (an additional 1 million in Canada).

[June 20, 2024 CPSC](#); MM Products recalled its JoyJolt Drinkware Declan Single-Wall Glass Coffee Mugs because the glass mugs can break and crack when filled with hot liquids, posing burn and laceration hazards. Units: About 580,000.

[June 20, 2024 CPSC](#); myCharge recalled its POWER HUB All-In-One 10,000mAh

portable chargers because the portable chargers can overheat while charging, posing fire and burn hazards. Units: About 567,000.

[June 20, 2024 CPSC](#); Vitamix reannounced and expands its recall of Vitamix Ascent® Series and Venturist® Series 8-ounce and 20-ounce Blending Containers and Blade Bases because the containers can separate from the blade base, exposing the blades, posing a laceration hazard to consumers. Units: About 569,000 (an additional ~121,950 in Canada).

[June 20, 2024 CPSC](#); StyleCraft recalled its Instinct Professional Vector Motor Cordless Hair Clippers because the lithium-ion battery in the recalled clippers can overheat, posing fire and burn hazards. Units: About 50,000 (an additional ~1,320 in Canada).

[June 20, 2024 CPSC](#); The Cedona Natural View six-drawer dressers, sold exclusively at Rooms To Go, have been recalled because they are unstable if they are not anchored to the wall, posing serious tip-over and entrapment hazards that can result in injuries or death to children. The dressers do not comply with the performance requirements of the STURDY Act. Units: About 400.

[June 13, 2024 CPSC](#); Bambu Lab recalled its A1 3D printers because the printer's heatbed cable is bent or damaged, it can short-circuit and spark or burn through the insulation layer, posing electric shock and fire hazards. Units: About 12,800.

[June 13, 2024 CPSC](#); Adven Group recalled its Nap Queen Sleep Victoria Hybrid Mattresses because they violate mandatory federal flammability regulations for mattresses, posing a fire hazard to consumers. Units: About 117,200.

[June 13, 2024 CPSC](#); The 1 Set Puzzle "Magnetic", "Magnetism", or "Magnetism Intelligence Strategy Game" Magnetic Battle Chess Games, sold exclusively on Temu.com through Outad Good Life, have been recalled because they do not comply with the requirements of the mandatory federal toy regulation and pose a risk of serious injury or death if ingested by children. When two or more small, powerful magnets are swallowed, surgery is often needed to remove them and fix the damage. Units: About 2,600.

[June 13, 2024 CPSC](#); Daikin Comfort Technologies Manufacturing recalled its Amana, Daikin, and Goodman branded air conditioning and heat pump packaged units because the unit's can have incorrect electrical ratings which can lead to incorrect wirings being used, posing a fire hazard. Units: About 12,100.

[June 6, 2024 CPSC](#); SA Consumer Products recalled its Sanctuary and Sports Afield Biometric Firearm Safes because the lock on the gun safes can be opened by unauthorized users, posing a serious injury hazard and risk of death. Units: About 133,370.

[June 6, 2024 CPSC](#); Good Earth Lighting recalled its Good Earth Rechargeable Integrated Lights because the light's battery can overheat and ignite the light's plastic housing, posing fire and burn hazards to consumers. Units: More than 1.2 million (an additional ~37,800 in Canada).

[June 6, 2024 CPSC](#); The Sling Carriers, sold on Walmart.com through Joybuy Marketplace Express, have been recalled because they violate the safety requirements of the Safety Standard for Sling Carriers, including requirements for structural integrity and occupant retention, posing a fall hazard to babies. The carriers also pose a suffocation hazard because they fail to meet the federal safety standard's requirements for restraint systems. Units: About 1,160.

## RECALLS

[June 27, 2024 CPSC](#); Daikin Comfort Technologies Manufacturing recalled its Daikin FIT, Amana Brand S-series, and Goodman SD heat pumps because a power interruption in the heat pump can result in the product providing heat when the power resumes, despite the thermostat being in cooling mode, posing a risk of excessive heat exposure to consumers. Units: About 56,000 (an additional ~5,522 in Canada).

[June 27, 2024 CPSC](#); The Baseus Magnetic Wireless Charging Power Banks, sold at Amazon.com, AliExpress.com and Baseus.com, have been recalled because the lithium-ion battery in the power banks can overheat, posing a fire hazard. Units: About 132,000.

[June 27, 2024 CPSC](#); Southern Telecom recalled its Brookstone TurboVac Handheld Rechargeable Vacuums because the vacuums can short circuit during or after charging the battery, posing a fire hazard. Units: About 10,600.

[June 27, 2024 CPSC](#); At Home Procurement recalled its Tie Dye Fur Toy Trunk Storage Chests because the toy trunk storage chests do not contain a lid support feature or ventilation holes, posing entrapment and suffocation hazards. Units: About 990.

[June 27, 2024 CPSC](#); REI recalled its Co-op Cycles REV 12-, 16-, or 20-inch Kid's Bicycles with training wheels because the training wheel assembly knob can loosen and detach from the bicycle, posing fall and injury hazards to the riders. Units: About 75, 860.

[June 25, 2024 CPSC](#); Dania Furniture recalled its Hayden Bookcase because the bookcase is unstable if it is not anchored to the wall, posing tip-over and entrapment hazards that can result in death or serious injuries to children. Units: About 940.

[June 25, 2024 CPSC](#); MGA Entertainment recalled its Miniverse Make It Mini Sets

with Liquid Resins because the sets contain resins that, when liquid, can cause skin, eye, and respiratory irritation or sensitization when inhaled, touched, or ingested by children or adults. The resins contain acrylates (hydroxyethylmethacrylate “HEMA” and isobornyl acrylate “IBOA”) in amounts prohibited in children’s products by the Federal Hazardous Substances Act. After the resins cure, they no longer present this hazard. Units: About 21 million (an additional 1 million in Canada).

[June 20, 2024 CPSC](#); Thousandshores recalled its Theefun Kids Gardening Tools Sets because the brown handle strings contain levels of phthalates that exceed the federal phthalate ban. Phthalates are toxic if ingested by young children and can cause adverse health effects. Units: About 500.

[June 20, 2024 CPSC](#); Cinmar recalled its Frontgate Resort Collection Newport Aluminum and Teak Chaises because when adjusting the backrest while seated, the adjustable backrest can unexpectedly descend with force, posing finger crushing and amputation hazards. Units: About 70,000.

[June 20, 2024 CPSC](#); The Cargo Bicycles, manufactured by Babboue B.V., have been recalled because the frames of the bicycles can crack and can bend and break, posing a fall hazard to the rider. Units: About 300 (an additional ~445 in Canada).

[June 20, 2024 CPSC](#); MM Products recalled its JoyJolt Drinkware Declan Single-Wall Glass Coffee Mugs because the glass mugs can break and crack when filled with hot liquids, posing burn and laceration hazards. Units: About 580,000.

[June 20, 2024 CPSC](#); myCharge recalled its POWER HUB All-In-One 10,000mAh portable chargers because the portable chargers can overheat while charging, posing fire and burn hazards. Units: About 567,000.

[June 20, 2024 CPSC](#); Vitamix reannounced and expands its recall of Vitamix Ascent® Series and Venturist® Series 8-ounce and 20-ounce Blending Containers and Blade Bases because the containers can separate from the blade base, exposing the blades, posing a laceration hazard to consumers. Units: About 569,000 (an additional ~121,950 in Canada).

[June 20, 2024 CPSC](#); Goal Zero recalled its Yeti Link Expansion Modules and EC8 Cables because the connection between the Yeti Link Expansion modules and the cables can overheat and melt, posing fire and burn hazards. Units: About 34,460 (an additional ~815 in Canada).

[June 20, 2024 CPSC](#); StyleCraft recalled its Instinct Professional Vector Motor Cordless Hair Clippers because the lithium-ion battery in the recalled clippers can overheat, posing fire and burn hazards. Units: About 50,000 (an additional ~1,320 in Canada).

[June 20, 2024 CPSC](#); Orly recalled its Lavender scented candles in a round

wooden bread bowl because the candle's flames can reach excessive heights and can ignite the bowl, posing fire and burn hazards. Units: About 3,600.

[June 20, 2024 CPSC](#); The Cedona Natural View six-drawer dressers, sold exclusively at Rooms To Go, have been recalled because they are unstable if they are not anchored to the wall, posing serious tip-over and entrapment hazards that can result in injuries or death to children. The dressers do not comply with the performance requirements of the STURDY Act. Units: About 400.

[June 13, 2024 CPSC](#); Bambu Lab recalled its A1 3D printers because the printer's heatbed cable is bent or damaged, it can short-circuit and spark or burn through the insulation layer, posing electric shock and fire hazards. Units: About 12,800.

[June 13, 2024 CPSC](#); Adven Group recalled its Nap Queen Sleep Victoria Hybrid Mattresses because they violate mandatory federal flammability regulations for mattresses, posing a fire hazard to consumers. Units: About 117,200.

[June 13, 2024 CPSC](#); The 1 Set Puzzle "Magnetic", "Magnetism", or "Magnetism Intelligence Strategy Game" Magnetic Battle Chess Games, sold exclusively on Temu.com through Outad Good Life, have been recalled because they do not comply with the requirements of the mandatory federal toy regulation and pose a risk of serious injury or death if ingested by children. When two or more small, powerful magnets are swallowed, surgery is often needed to remove them and fix the damage. Units: About 2,600.

[June 13, 2024 CPSC](#); Southern Telecom recalled its Lomi Roll-On Waxing Kits because the roll-on warmer's power cord can overheat and short circuit, posing fire, burn, and electrical shock hazards. Units: About 19,500.

[June 13, 2024 CPSC](#); Black Diamond Equipment recalled its Neve Strap Crampons and Accessory Kits because the screws that connect the plastic heel cup to the aluminum heel unit of the crampon can loosen and allow the heel cup to detach from the crampon, posing a fall hazard. Units: About 350 (an additional ~28 in Canada).

[June 13, 2024 CPSC](#); Retrospec recalled its Beaumont Plus ST Bikes with disc brakes because the front disc brake rotor and brake pads can be misaligned, which can cause brake failure, posing crash and injury hazards. Units: About 530.

[June 13, 2024 CPSC](#); Daikin Comfort Technologies Manufacturing recalled its Amana, Daikin, and Goodman branded air conditioning and heat pump packaged units because the unit's can have incorrect electrical ratings which can lead to incorrect wirings being used, posing a fire hazard. Units: About 12,100.

[June 12, 2024 FDA](#); Suntegrity Skincare recalled its Sunscreen foundation because the product contains higher than acceptable microbiological mold count, posing a risk of allergic skin reaction and/or primary fungal skin infection.

[June 6, 2024 CPSC](#); Kawasaki Motors USA recalled the engines used in Bad Boy Mowers, BigDog, Bobcat, Cub Cadet, Hustler, John Deere, and Kubota brand lawn and garden equipment because the engines can overheat, posing fire and burn hazards. Units: About 68,500 (an additional ~900 in Canada).

[June 6, 2024 CPSC](#); SA Consumer Products recalled its Sanctuary and Sports Afield Biometric Firearm Safes because the lock on the gun safes can be opened by unauthorized users, posing a serious injury hazard and risk of death. Units: About 133,370.

[June 6, 2024 CPSC](#); Good Earth Lighting recalled its Good Earth Rechargeable Integrated Lights because the light's battery can overheat and ignite the light's plastic housing, posing fire and burn hazards to consumers. Units: More than 1.2 million (an additional ~37,800 in Canada).

[June 6, 2024 CPSC](#); The Sling Carriers, sold on Walmart.com through Joybuy Marketplace Express, have been recalled because they violate the safety requirements of the Safety Standard for Sling Carriers, including requirements for structural integrity and occupant retention, posing a fall hazard to babies. The carriers also pose a suffocation hazard because they fail to meet the federal safety standard's requirements for restraint systems. Units: About 1,160.

[June 6, 2024 CPSC](#); Spectrum Brands Pet Care recalled its FURminator deShedding Ultra Premium Dog Conditioner (1 Gallon) because it can contain bacteria, including Pseudomonas aeruginosa, which can enter the body if inhaled, through the eyes, or through a break in the skin. People with weakened immune systems or external medical devices who are exposed may require medical treatment. Units: About 102,000 (an additional ~250 in Canada).
