### CPSC Issues Consumer Warnings on Gas Fireplaces, Electric Skateboards, High Powered Magnets, and More

Throughout the month of May, the Consumer Product Safety Commission (CPSC) issued several public health and safety notices to consumers, warning the public to stop using products posing a range of hazards. These unilateral warnings are issued because the manufacturers have not agreed to a recall or offered a remedy to consumers:

- [Floatwheel Electric Skateboard](#): Fall and Crash Hazard; Risk of Serious Injury and Death.
- [Floatstep Dock Ladders](#): Risk of Fingertip Amputation and Crushing Injuries.
- [Mega-Tac Permanent Adhesive](#): Poisoning Hazard; Violation of the Federal Hazardous Substances Act (FHSA)
- [Magnetic Bracelets and Heart-Shaped Magnets](#): Ingestion Hazard; Violation of the Federal Regulation for Magnets.
- [Wifi/Wifi0306 Magnetic Games](#): Ingestion Hazard; Violation of Federal Safety Regulations for Magnet Toys.
- [Lihailidebeimeidianpu Magnetic Chess Games](#): Ingestion Hazard; Violation of Federal Safety Regulations for Magnet Toys.
- [Guo Yumei/Ssping Magnetic Games](#): Ingestion Hazard; Violation of Federal Safety Regulations for Magnet Toys.

## TOP RECALLS

[May 30, 2024 CPSC](#); The crib bumpers, sold by Henan Ouchang Trading and Xinxiang Junshun Trading on AliExpress, have been recalled because infants can suffocate if they roll or move on the crib bumper in a position that obstructs breathing. Padded crib bumpers are banned under federal law. Units: About 75.

[May 30, 2024 CPSC](#); Compare Brands recalled its ADIOS! Super Vinegar All Natural Cleaner, sold exclusively on Amazon, because the product violates the Federal Hazardous Substances Act because it is deceptively labeled as “Safe to Use” and lacks the required cautionary statements for a poison, posing a risk of poisoning and chemical burns to consumers. Units: About 2,420.

[May 23, 2024 CPSC](#); The TOPINCN Pool Drain Covers, sold exclusively on Amazon by Sanure, because they do not conform to the entrapment protection standards of the Virginia Graeme Baker Pool and Spa Safety Act (VGBA), posing an entrapment hazard to swimmers and bathers. Units: About 340.

[May 16, 2024 CPSC](#); The CHZHVAN Combination Smoke and Carbon Monoxide Detectors, sold exclusively on Amazon by Haikouhuidishangmaoyouxiangongsi have been recalled because the detectors can fail to activate, posing a risk that consumers will not be alerted to a fire. Units: About 6,800.

[May 16, 2024 CPSC](#); Electrolux Group recalled its Frigidaire and Kenmore Smooth-top Freestanding Electric Ranges because, depending on the model, the surface heating elements can: 1) turn on spontaneously without being switched on; 2) fail to turn off after being switched off; or 3) heat to different temperatures than selected. This poses fire and burn hazards to consumers. Units: About 203,000.

[May 9, 2024 CPSC](#); The Zegoo Children’s Nightgowns, sold exclusively on Amazon and imported by Zegoo Home, because they violate the flammability standards for children’s sleepwear, posing a risk of burn injuries to children. Units: About 14,000.

[May 9, 2024 CPSC](#); The children’s robes, sold exclusively on Amazon and imported by SIORO, have been recalled because they violate the flammability standards for children’s sleepwear, posing a risk of burn injuries to children. Units: About 5,000 (an additional ~950 recalled previously).

[May 9, 2024 CPSC](#); Cotton On USA recalled its toy pinwheels because the fastener cap can come loose and detach, posing a choking hazard to young children. Units: About 8,500.

[May 9, 2024 CPSC](#); ZLINE recalled its Wall Ovens because the oven door hinge can dislodge, releasing the spring, which can damage or break through the door trim, posing an impact injury hazard to consumers. Units: About 5,000.

[May 2, 2024 CPSC](#); Dixon Ticonderoga recalled its Creativity Street Foam Pattern Rollers because they are intended for children and contain levels of lead that exceed the federal lead content ban in the rollers’ handles. Lead is toxic if ingested by young children and can cause adverse health effects. Units: About 2,880 (an additional ~24 in Canada).

[May 2, 2024 CPSC](#); The Mill Valley Jr. six-drawer youth dressers, sold exclusively at Rooms To Go, have been recalled because they are unstable if they are not properly anchored to the wall, posing serious tip-over and entrapment hazards

that can result in injuries or death to children. The dressers violate the performance requirements of the STURDY Act. Units: About 200.

[May 2, 2024 CPSC](#); Skims Body recalled its SKIMS Children's Pajama Sets because the sets fail to meet the flammability regulations for children's sleepwear, posing a risk of burn injuries to children. Units: About 1,200 (an additional ~23 in Canada).

[May 2, 2024 CPSC](#); Igloo Products recalled its Youth Sipper Bottles because the silicone cover on the sipper can detach while in use, posing a choking hazard to children. Units: About 31,500.

## RECALLS

[May 30, 2024 CPSC](#); The crib bumpers, sold by Henan Ouchang Trading and Xinxiang Junshun Trading on AliExpress, have been recalled because infants can suffocate if they roll or move on the crib bumper in a position that obstructs breathing. Padded crib bumpers are banned under federal law. Units: About 75.

[May 30, 2024 CPSC](#); Black & Decker recalled its CRAFTSMAN® V20 Cordless Tillers/Cultivators because the assembly instructions can cause consumers to incorrectly attach the bottom portion of the tiller/cultivator upside down, causing the tines to rotate toward the user, posing a laceration hazard. Units: About 44,400.

[May 30, 2024 CPSC](#); Compare Brands recalled its ADIOS! Super Vinegar All Natural Cleaner, sold exclusively on Amazon, because the product violates the Federal Hazardous Substances Act because it is deceptively labeled as "Safe to Use" and lacks the required cautionary statements for a poison, posing a risk of poisoning and chemical burns to consumers. Units: About 2,420.

[May 23, 2024 CPSC](#); The TOPINCN Pool Drain Covers, sold exclusively on Amazon by Sanure, because they do not conform to the entrapment protection standards of the Virginia Graeme Baker Pool and Spa Safety Act (VGBA), posing an entrapment hazard to swimmers and bathers. Units: About 340.

[May 16, 2024 CPSC](#); Kano Laboratories recalled its Super Lube Syncopen Synthetic Penetrant, Super Lube Fire Resistant Hydraulic Fluid, and Super Lube Metal Protectant and Corrosion Inhibitor (consumer sizes of five gallons or less) because the product is not child resistant, posing a risk of poisoning if the contents are swallowed by young children. Additionally, petroleum distillates can get into the lungs, causing chemical pneumonia and/or pulmonary damage, which can be fatal. Units: About 3,700.

[May 16, 2024 CPSC](#); The CHZHVAN Combination Smoke and Carbon Monoxide Detectors, sold exclusively on Amazon by Haikouhuidishangmaoyouxiangongsi have been recalled because the detectors can fail to activate, posing a risk that

consumers will not be alerted to a fire. Units: About 6,800.

[May 16, 2024 CPSC](#); Electrolux Group recalled its Frigidaire and Kenmore Smooth-top Freestanding Electric Ranges because, depending on the model, the surface heating elements can: 1) turn on spontaneously without being switched on; 2) fail to turn off after being switched off; or 3) heat to different temperatures than selected. This poses fire and burn hazards to consumers. Units: About 203,000.

[May 9, 2024 CPSC](#); The Zegoo Children's Nightgowns, sold exclusively on Amazon and imported by Zegoo Home, because they violate the flammability standards for children's sleepwear, posing a risk of burn injuries to children. Units: About 14,000.

[May 9, 2024 CPSC](#); The Spin Swivel Chairs, sold exclusively at Article, have been recalled because the swivel chair's base can break, posing a fall hazard. Units: About 4,500 (an additional ~140 in Canada).

[May 9, 2024 CPSC](#); The Korimefa Multi-Purpose Bike Helmets, sold exclusively on Amazon and imported by Yangxi, have been recalled because they do not comply with the positional stability requirements of the CPSC federal safety standard for bicycle helmets. The helmets can fail to protect in the event of a crash, posing a risk of head injury. Units: About 60.

[May 9, 2024 CPSC](#); The children's robes, sold exclusively on Amazon and imported by SIORO, have been recalled because they violate the flammability standards for children's sleepwear, posing a risk of burn injuries to children. Units: About 5,000 (an additional ~950 recalled previously).

[May 9, 2024 CPSC](#); Cotton On USA recalled its toy pinwheels because the fastener cap can come loose and detach, posing a choking hazard to young children. Units: About 8,500.

[May 9, 2024 CPSC](#); ZLINE recalled its Wall Ovens because the oven door hinge can dislodge, releasing the spring, which can damage or break through the door trim, posing an impact injury hazard to consumers. Units: About 5,000.

[May 2, 2024 CPSC](#); Bausch + Lomb recalled its Project Watson Eyelid Wipes for Dogs because when they are opened and in use, bacteria and fungi, which are organisms found widely in the environment, soil, and water, can be introduced and grow in the container, posing a risk of serious infection to people with weakened immune systems. Individuals with wounds may also be at higher risk of infection. People with healthy immune systems are not typically affected.

[May 2, 2024 CPSC](#); Dixon Ticonderoga recalled its Creativity Street Foam Pattern Rollers because they are intended for children and contain levels of lead that exceed the federal lead content ban in the rollers' handles. Lead is toxic if ingested by young children and can cause adverse health effects. Units: About 2,880 (an additional ~24 in Canada).

[May 2, 2024 CPSC](#); American Honda Motor expanded its recall of Honda Lawnmowers, Replacement Engines, and Pressure Washers Engines because

the improperly manufactured camshafts in the engines can cause the starter rope to suddenly retract when pulling to start, posing an injury hazard. Units: About 200 (an additional ~391,800 previously recalled).

[May 2, 2024 CPSC](#); True Manufacturing recalled its Commercial Refrigerators with Secop Compressors because they can fail in a manner causing the compressor to overheat, posing a fire hazard. Units: About 29,200 (an additional ~50 in Mexico).

[May 2, 2024 CPSC](#); The Mill Valley Jr. six-drawer youth dressers, sold exclusively at Rooms To Go, have been recalled because they are unstable if they are not properly anchored to the wall, posing serious tip-over and entrapment hazards that can result in injuries or death to children. The dressers violate the performance requirements of the STURDY Act. Units: About 200.

[May 2, 2024 CPSC](#); Skims Body recalled its SKIMS Children's Pajama Sets because the sets fail to meet the flammability regulations for children's sleepwear, posing a risk of burn injuries to children. Units: About 1,200 (an additional ~23 in Canada).

[May 2, 2024 CPSC](#); Igloo Products recalled its Youth Sipper Bottles because the silicone cover on the sipper can detach while in use, posing a choking hazard to children. Units: About 31,500.
